#### Introduction

#### Similarities:

- former working class and industrial neighbourhood;
- inner-city neighbourhood Vltava embankment;
- development started around the same period intensively, especially in Karlín;

#### Differences:

- size;
- development trajectories;
- housing and districts (housing estates in Karlín and villa districts in Smíchov).

# Urban transformation and gentrification-like processes

Two preconditions of Prague's development and gentrification:

- 1. "geographic position, historical heritage, economic power, and cultural tradition" (Ouředníček & Temelová, 2009, p. 25);
- 2. during socialism the central and inner-city housing stock was neglected, which created a fertile ground for investments and redevelopment (Sýkora, 1993).

Gentrification started as a construction business of foreign investors and developers targeting and fulfilling the consumption preferences of foreigners from western countries who can afford a luxurious lifestyle (Sýkora, 1996, 2005).

Reurbanization (Ouředníček et al., 2015) or new-build gentrification (Cook, 2010).

Commercialisation (Sýkora, 1999; Pixová & Sládek, 2016) - mainly in new Karlin and around Anděl public transportation hub in Smíchov.

Rejuvenation by transitory young urbanites and childless households (Haase et al., 2012; Kährik et al., 2015) or *in situ* social upgrading (Temelová et al., 2016).

Karlín (Jindrová, 2014; Richterová, 2015; Vaněk, 2021) and Smíchov (Kolomazníková, 2020) - displacement (mainly Roma and elderly), urban regeneration, deindustrialisation, hipsterfication, commercialisation, etc.

# Methodology

#### Research goals and question

Compare and explain the socio-demographic composition of in-migration and out-migration populations from potentially gentrified neighbourhoods in the inner-city of Prague in the period between 2000 and 2020.

Who is moving in and out of Karlín and Smíchov?


#### Methods

- → Analysis of migration data (2010-2020)
  - age, marital status, citizenship and place of in- and out-migration
- → Analysis of population census (2011-2021)
  - + education, professional structure
  - Not available yet in required detail

#### **Data sources**

- → Evidence of migration statistic
  - yearly numbers
- → Population census (2011-2021)
  - census which is not available in detail for neighbourhoods


### Age structure\_ Karlín



- youngsters between 20-32 years old are moving into old Karlín, as well as 16-18 & 32-36;
- >37 years old are moving out from old Karlín;
- New Karlín and Invalidovna are relatively balanced, only a slight increase in young people between 16-34 age;
- this documents that social dynamics are absolutely different, two different types of migrational behaviour.


## Age structure \_Smíchov

#### Ann atmostome Confabrati




- Young people between 18 and 36 are moving into Smichov, especially Old Smichov;
- 36-50 relatively balanced;
- >50 moving out, with young children between the age 0 and 16.


#### Marital status\_ Karlín





- Very different Old Karlín receives only young singles, while losses other categories;
- Invalidovna is similar to new residential areas - reason: several new projects of new housing creates similarities, not the housing estate itself;
- in absolute numbers dominance of processes within the Old Karlín;
- almost 10k singles move in and out of Old Karlín balances the rest of the whole migrations.

#### Marital status\_Smíchov











- in-migration to Old Smíchov of singles is very high, compared to other marital status groups;
- a considerable number of married people move out, especially from old Smíchov, Those might be families with young children;
- slightly more divorced and widowed are moving out compared to those moving in, but the numbers are still small and probably negligible. This can be due to their age and tenure status, which make them less reluctant to move.


### Destination-origin\_Karlín






- Out-migration is high in Karlín of people moving to other parts of Prague, while in-migration of foreigners is high to Karlín, especially in the old Karlín;
- Migration from and to other parts of Prague is the most active.

## Destination-origin\_Smíchov





- Out-migration from Smíchov to other parts of Prague is high, especially old Smíchov;
- turnover of people moving in and out from and to other parts of Prague is the highest;
- Positive trend of people moving to Smíchov, especially old Smíchov, from abroad.





7	Other Global South countries	India, Vietnam, China, Thailand, Brazil, Bangladesh, etc.


Citizenship In-migration\_Karlín








#### Results

- Old Karlín young and single foreigners, Saldo positive balance of migration of singles;
- In-migration by singles, out-migration by married, divorced and widowed:
- Young families moving in with very young children 2-4 years old, while families with children 6-16 years old seem to move out from old Karlín;
- More foreigners moving into Karlin, and considerably more Czechs moving out. The dominant citizenships are covering all categories, and are relatively balanced.
- Young people between 18 and 36 are moving into Smichov.
   Families with young children and teenagers and moving out.
- Big turnover of singles (positive trend). The second biggest turnover is of married; however, the trend is negative. Divorced and widowed-balanced.

#### Interpretation

- slowly increasing mobility in the second half of 2010s
- more or less the same number of in and out migrants
- migration increase in 11 years is only 634 persons
- migration turnover is big
   twice more of the total
  population of the whole
  cadastral territory 21k

#### Conclusion

Rejuvenation by possibly transitory young urbanites and childless households

Internationalisation

Possible displacement of families with older children and eldrely population due to the land price increase

Commercialisation and new services, safety and other conditions might have attracted the single young foreigners

Potential gentrification?
